<u>Contest Period:</u>	<ol style="list-style-type: none">1. The Contest starts from 00:00:00, 15/05/2024 and ends on 23:59:59, 15/07/2024 (“Contest Period”). The Organiser reserves the right to change, cancel, terminate or suspend the Contest at any time during the Contest Period without prior notice.2.
