

TERMS AND CONDITIONS

<u>Organiser:</u>	F&N Beverages Marketing Sdn. Bhd. (Co. No. 004594-A)
<u>Contest:</u>	PERADUAN JOM SIHAT, KEKAL CERGAS EKSKLUSIF DI 7-ELEVEN (“Contest”).
<u>Contest Period:</u>	<ol style="list-style-type: none">1. The Contest starts from 00:00:00, 01/08/2024 and ends on 23:59:59, 31/08/2024 (“Contest Period”). The Organiser reserves the right to change, cancel, terminate or suspend the Contest at any time during the Contest Period without prior notice.2. For the avoidance of doubt, any cancellation, termination or suspension by the Organiser shall not entitle the Participants to any claim or compensation against the Organiser for any loss or damage suffered or costs and expenses incurred by the Participant either directly and/or indirectly arising from or in connection with the cancellation, termination or suspension of the Contest by the Organiser.

You are required to provide your Personal Details only once. You may submit as many Entries as you want, and all subsequent Entries will be linked to the Personal Details provided initially.</p> <p>f. An auto reply acknowledgement message will be sent by the Organiser for the first WhatsApp Entry received from each mobile number only.</p> <p>2. The Organiser will extract all Entries received for further processing. All Entries received are subject to the Organiser’s review and verification.
